The "ERMIS" Digital Portal is an electronic system, through which all procedures related to Plans and Systems of the HUMAN RESOURCES DEVELOPMENT AUTHORITY (HRDA) will now be processed.

All Businesses and Organizations that <u>wish to participate in training programs sponsored by the HRDA</u> must immediately proceed with the following actions:

- Actions concerning <u>Businesses/Organizations</u> participating in training programs with their <u>employees</u>:
- > Registration of an employer in the HRDA ERMIS register as a legal person or as a natural person or as a joint venture
- ➤ Obtaining the HRDA registration number and access code to the "ERMIS" system
- > Submit a request to obtain the "Employer" role

# Actions concerning Employees of Businesses/Organizations

- Registration of candidates for participation in the HRDA register as natural persons
- > Obtaining the HRDA registration number and access code to the "ERMIS" system
